- 9. Light conditions (position of bird in relation to shade and to direction and amount of light):

Mostly sunny skies. Wind Beaufort scale 2 on 12 Dec and Beaufort scale 4 on 2 Mar.

10. Optical equipment (type, power, condition): N/A (all heard only)

- 11. Distance to bird(s): ranging from <10 m to 50-100 m.
- 12. Duration of observation: a few seconds or minutes for each bird
- 13. Habitat: Coastal high salty marsh dominated by *Spartinae spartinae*, *Borrichia frutescens*, and scattered *Baccharis*
- 14. Behavior of bird / circumstances of observation (flying, feeding, resting; include and stress habits used in identification; relate events surrounding observation): Detected during Audubon Louisiana point counts, funded by LDWF and USFWS. Five point counts at this site, each separated by at least 400 m, ensuring independence between survey points. All birds heard calling/singing.

#1 - BLRA was ~6m away and started doing growl call. Growled a couple times in response to playback. Possibly a second one but I think was just the one moving. Got recording of growl.

#2 - BLRA growled a couple of times during BLRA playback. Was ~5m away from me. Couldn't get recording of growl.

2 Mar 2018

#1 & #2 - Black Rail responded to playback around minute 4. Sang kikidrr from ~25m away. Heard second further back 35-40m singing kikidrr as well. Got recording, they sang for 3-4 minutes.

#3 & #4 & #5 - Heard Black Rail singing (kikidrr) as I was arriving to point. Got to point and this BLRA was singing S ~25m away, while 2 more were singing (30 and 50m). South BLRA got closer as I did playback. Got recording.

#6 & 7 - Heard faint kikidrr during BLRA playback but couldn't get direction/distance. During CLRA playback 2 Black Rails (E and W, both 60-75m away sang kikidrr briefly. No recording.
