1. English and Scientific names: Black Rail (*Laterallus jamaicensis*)

2. Number of individuals, sexes, ages, general plumage (e.g., 2 in alternate plumage): 4 caught and banded on two different dates (no recaptures); 1 heard only detection representing 1 individuals. Minimum of 4 birds present in this record. Additional winter 2017-2018 records (submitted separately) indicate a minimum of 5 birds at this site from Nov 2017 to March 2018.

3. Parish: Cameron

Specific Locality: John Allaire property (private), west jetty area, between Calcasieu Pass and Holly Beach, and between LA-82 and the beach.

4. Date(s) when observed:

- Caught and banded all between 30 minutes after sundown and midnight: 3 Mar 2018 (2x), 26 Mar 2018 (2x)

- Heard only: 6:37am 4 Mar 2018

5. Time(s) of day when observed: all banding records between sundown and midnight.

No other observers during point count heard only records.

8. Other observers who independently identified the bird(s):

None known. These would be different birds than anything that could be heard from LA-82 by other birders.

9. Light conditions (position of bird in relation to shade and to direction and amount of light):

Birds caught at night in dark using spotlights. Heard bird during Beaufort 3 winds.

10. Optical equipment (type, power, condition): None

11. Distance to bird(s): All heard birds <25 meters. 4 birds in hand.

12. Duration of observation: A few seconds for the heard birds. ~10 minutes in hand.

13. Habitat: High salty marsh, dominated by *Spartina spartinae*, *Baccharis*, and *Borrchia frutescens*

14. Behavior of bird / circumstances of observation (flying, feeding, resting; include and stress habits used in identification; relate events surrounding observation):

Heard birds in response to playback during Audubon Louisiana point count surveys funded by LDWF and USFWS.

Heard birds:

4 Mar 2018 – JL: Heard BLRA growl West at ~10m during minute 4. Eventually got closer (~3m) and growled again at minute 6. Only those 2 vocalizations. No recording.

Similar species (include how they were eliminated by your observation): The variety of birds usually found in the grass layer of this kind of habitat is relatively limited, but include a variety of rails (all 5 salt-living rails), Sedge Wren, and a few sparrows (primarily Swamp, Nelson's, Seaside). The growl calls of Black Rail aren't like those of Virginia Rail or Sora, although some of the "kip"/"ik" calls can be close. Sedge Wren and Swamp Sparrow also give various growl-like calls, but of a different quality, being less gritty. Black Rail growls sound like a little engine starting up.

19. Previous experience with this species: Minimal, a few heard only birds as well as a few captured in Texas with crews there.
