- 8. Other observers who *independently identified* the bird(s): None.
- 9. Light conditions (position of bird in relation to shade and to direction and amount of light): Sunny. Mid-day light, various angles.

- 11. Distance to bird(s): Less than 500 m (distance not noted in field notes, so basing on memory 6 months later)
- 12. Duration of observation: A few minutes
- 13. Habitat: blue water, unsure of depth Google Earth suggests 950 feet.
- 14. Behavior of bird / circumstances of observation (flying, feeding, resting; include and stress habits used in identification; relate events surrounding observation):

  Seen in flight, banking above and below horizon, occasional flapping more bulky in nature than a small shearwater like Audubon's.
- 15. Description (include only what was actually seen, *not what "should" have been seen;* include if possible: total length/relative size compared to other familiar species; body bulk, shape, proportions; bill, eye, leg, and plumage characteristics. Stress features that separate it from similar species, *or for species that are known to hybridize frequently, stress features that help eliminate possible hybrids*):

Description largely based on photos, as I spent the majority of the observation trying to get documentation of a variety of angles of the bird. Pale brown upper parts and all white underparts. Wings were mostly white below, with the white extending into the outer primaries. Leading and trailing edge and wing tips dark brown. Bill straw-yellow with dark tip. From my photos, it appeared the bird was molting to about p5.

- 16. Voice: Not heard.
- 17. Similar species (include how they were eliminated by your observation): Clearly in the "Cory's complex" combination of upperpart color and underpart pattern eliminates other shearwaters and petrels. Cape Verde and possibly Cory's "borealis" eliminated by extensive white extending into the underside of the primaries. Cape Verde also eliminated by paler head and paler (and more yellowish) bill.

- 19. Previous experience with this species: Seen on most of the 6-8 Louisiana pelagics I've been on, including many last fall, but experience is sporadic.
