- 11. Distance to bird(s): approx. 15 to 30 ft (to feeders), 25 ft (to bush in backyard)
- 12. Duration of observation: Intermittently for approx. 30 minutes
- 13. Habitat: Urban/rural mix, small neighborhood just outside of city limits, backyard of private residence, some plants and trees, grass yard, fields surrounding neighborhood, with a few hummingbird feeders set up under carport.
- 14. Behavior of bird / circumstances of observation (flying, feeding, resting; include and stress habits used in identification; relate events surrounding observation): Observed hummingbird flying and feeding at and around feeder, and resting perched on a branch close by in a shrub/tree.
