Behavior of bird / circumstances of observation (flying, feeding, resting; include and stress habits used in identification; relate events surrounding observation): **I spotted the bird in a roadside tree while we were at a stop sign. It flew and we re-found it twice as it worked its way northwestward up the island.**

**A dull Red-eyed type vireo with brown malar stripes. Facial pattern less crisp and distinctly colored than typical spring Red-eyed. Not studied closely—trying to relocate and get photos as it moved and re-located.**
