One bird was seen, age and sex unknown. Bird was in bright fresh fall plumage.

9. Light conditions (position of bird in relation to shade and to direction and amount of light):

The photographs were taken before the bird was observed with binoculars. There was decent midday sunlight but some obscuring of the bird from shrubbery. The bird flew up into a small goldenrain tree and was then observed with binoculars. The bird was quickly moving in the tree feeding but we were able to get good looks in good light.

Canon 7D Mark II with a Canon 400mm f/4 prime lens. New camera and lens.

12. Duration of observation:

1 minute

13. Habitat:

Couturie Forest is part of New Orleans City Park. It has a large concentration of mature Live Oaks and a mix of native and non-native plantings. There is a gravel road through the forest that runs behind a large oak grove where the bird was located.

14. Behavior of bird / circumstances of observation (flying, feeding, resting; include and stress habits used in identification; relate events surrounding observation):

The bird was first seen perched on a branch 3 feet above the ground on the edge of the gravel road. It flew up as I got closer and foraged in a small tree above my head.

15. The bird looked larger than a warbler and was a bright olive green coloring on its dorsal surface with pale yellow underparts. It had a white supercilium and dark eyeline through its eye with a gray crown. I saw a dark lateral throat stripe and called James over to ask if he could look at the bird as I suspected I had a Black-whiskered Vireo.

The bird was silent

17. Similar species (include how they were eliminated by your observation):

It had a similar appearance as a Red-eyed Vireo but the lateral throat stripe was seen clearly.
