These are the whiskers Wendy Billiot sent me a video this morning asking my help identifying a bird that could be heard but not seen. First thought was a Chuck-wils-Widow. Then I used Merlin that suggested BWVI. Since I can't drive for a while I asked my friend Judy Robicheaux to drive me The BWVI was a lifer for her and year bird #297 for me. I never thought I'd get a year bird during my recovery.
