- 11. Optical equipment (type, power, condition): 10x binoculars, 600mm camera lens
- 12. Distance to bird(s): 60ft
- 13. Duration of observation: continual over about 1 hour; observed at least two CAKI and recorded their vocalizations. Birds remained present when other birders arrived and stayed throughout. They displaced briefly when an AMKE came to the electrical wire they were frequenting but returned not long thereafter.
- 14. Habitat: Electrical wires, tops of oak trees on edges of open grassy areas.

- 15. Behavior of bird / circumstances of observation (flying, feeding, resting; include and stress habits used in identification; relate events surrounding observation): Flycatching sallying out and returning to the same spot (usually on the electrical wires) and then sometimes at the top of the oak trees. At one point two of the birds I felt were clearly CAKI harassed and chased off the TRKI candidate bird. They preferred the electrical wires to themselves and chased the possible TRKI down to the chain link fence.
- 16. Description (include only what was actually seen, not what "should" have been seen; include if possible: total length/relative size compared to other familiar species, body bulk, shape, proportions, bill, eye, leg, and plumage characteristics. Stress features that separate it from similar species):

Kingbird with dark grey head and pale white mustache/beard like pattern. Gray throat with U shape like a bib transitioning to a yellow bellow. Back was grey with a yellow tint.

- 17. Voice: Calling -- multiple episodes of a call that sounded like "free-beer", "free-beer" and then interacting and calling.
- 18. Similar species (include how they were eliminated by your observation): WEKI -- there were WEKI present. I was able to get 6-8 decent recordings of the CAKI and Merlin agreed Cassins. Merlin had also (separately) picked up the WEKI nearby so it seemed like Merlin was able to differentiate the two different species in the field under those specific conditions without any difficulty. The audio recordings are cotemporaneous to the photos and I was certain it was the CAKI candidates making the calls.
