6. Time(s) of day when observed: Photo was taken at 9:53 a.m. I noticed the bird looked different to me and got the group together to see if we could all get another look. We had three carloads of observers and were able to play a mob tape and get the bird to come in. At that point multiple people were able to observe the bird and note it being a paler bird than a Blue-headed Vireo with a softer contrast between the cheek and throat.

9. Other observers who independently identified the bird(s): There were 3 cars of people. I don't know who else was able to identify the bird at this time.

10. Light conditions (position of bird in relation to shade and to direction and amount of light): It was overcast but the bird was seen unobstructed in a bare tree.

11. Optical equipment (type, power, condition): Canon EOS R5 RF100-500mm F4.5-7.1 L IS USM Zeiss SF Victory 10 x 42

12. Distance to bird(s): 80 Ft for the photos and then 15-25 feet in the trees and shrubs.

13. Duration of observation: The bird was observed for less than 30 seconds for the photo but several minutes while we played the tape and the bird moved in and out of branches.

14. Habitat: The levee along the lake has a waterway lined with trees and shrubs, mostly deciduous, and a mix of native plants.

We were able to get multiple photos but the bird did not move position much until it dropped out of sight. I drove up to the 2 cars in front of me and told David I saw a different looking vireo and wanted to try to draw it in. David played multiple tapes getting the bird to come in. Peter and David got good looks and were in agreement that they believed the bird to be a Cassin's Vireo.
