14. Behavior of bird / circumstances of observation (flying, feeding, resting; include and stress habits used in identification; relate events surrounding observation): Originally flushed by Eastern Phoebe, then seen sallying for dragonflies in canopy, then at rest

Stress features that separate it from similar species, *or for species that are known to hybridize frequently, stress features that help eliminate possible hybrids*): Large, yellow-bellied kingbird with gray head, solid colored tail, yellowish-green back, fairly hefty bill.

16. Voice: Gave contact call notes, "eek, eek!" Distinct voice

Western/Cassin's Kingbird eliminated immediately due to color of back and bill size.
Tropical Kingbird eliminated by voice
