1. English and Scientific names: *Cory's "Scopoli's" Shearwater* (*Puffinus diomedea diomedea*)

2. Number of individuals, sexes, ages, general plumage (e.g., 2 in alternate plumage): 1, adult

3. Parish: *Plaquemines*

Specific Locality: *28.636, -89.162; 24.5 mi SE of mouth of Southwest Pass, MS River.*

4. Date(s) when observed: *22 September 2018*

8. Other observers who *independently identified* the bird(s): *None.*

9. Light conditions (position of bird in relation to shade and to direction and amount of light): *Sunny. Late-morning light, various angles.*

10. Optical equipment (type, power, condition): *Didn't use binoculars, only camera. New*

Nikon D7200, with Nikon 80-400 mm f/4.5-5.6 VR lens in used condition

11. Distance to bird(s): ~a few hundred feet to 1/4 mile, very roughly guessing.

12. Duration of observation: About one-two minutes

13. Habitat: blue water, unsure of depth – Google Earth suggests 1100 feet.

14. Behavior of bird / circumstances of observation (flying, feeding, resting; include and stress habits used in identification; relate events surrounding observation):

Jack Rogers spotted the bird. It was flying the entire time, mostly just above the water, occasionally getting some altitude (above horizon), as it banked.

15. Description (include only what was actually seen, *not what "should" have been seen*; include if possible: total length/relative size compared to other familiar species; body bulk, shape, proportions; bill, eye, leg, and plumage characteristics. Stress features that separate it from similar species, *or for species that are known to hybridize frequently, stress features that help eliminate possible hybrids*):

Pale brown upper parts and all white underparts. Wings were mostly white below, with the white extending into the outer primaries. Leading and trailing edge and wing tips dark brown. Bill straw-yellow with dark subterminal tip. From my photos, it appeared the bird was molting to about p6 or p7, and in Charlie Lyon's photos, it looks like p6.

16. Voice: Not heard.

17. Similar species (include how they were eliminated by your observation): Clearly in the "Cory's complex" – combination of upperpart color and underpart pattern eliminates other shearwaters and petrels. Cape Verde and Cory's "borealis" eliminated by extensive white extending into the underside of the primaries.

18. Photographs or tape recordings obtained? (by whom? attached?): Yes, photos attached.

19. Previous experience with this species: Seen on most of the 6-8 Louisiana pelagics I've been on, including many last fall, but experience is sporadic.

20. Identification aids: (list books, illustrations, other birders, etc. used in identification):

a. at time of observation: None.

b. after observation: Checked Sibley later that day, and subsequently have looked at Nat Geo 7<sup>th</sup> ED and Petrels, Albatrosses, and Storm-Petrels of N.A. (Howell 2012).
