- 9. Light conditions (position of bird in relation to shade and to direction and amount of light): As we circled and angled for better views, we often had sun at our backs and on birds.
- 10. Optical equipment (type, power, condition): **Vortex 12x, Nikon D3500 w/ 200 mm lens.**

- 11. Distance to bird(s): Various, but often within 50 yards
- 12. Duration of observation: **about 30 minutes of observation, and while COSH was not main focus, it was the species to filter out—they were very conspicuous.**
- 13. Habitat: "Moving east southeast in water more than 5000' deep, water temp about 93 degrees, approx. 6" to 1' seas. Air temp about 90. Wind northerly 5-10, skies w scattered clouds. Deep blue water, mostly featureless." per Muth on eBird list
- 14. Behavior of bird / circumstances of observation (flying, feeding, resting; include and stress habits used in identification; relate events surrounding observation): **Birds resting** on water or flying low and arcing around when flushed to land elsewhere near boat.
- 15. Brownish-gray and white shearwaters with pale, dark-tipped bills. Most birds appeared to be mottled due to molt; the overall color pattern and scaled upperparts made me think of Greater White-fronted Goose whenever I'd come across one sitting on the water. All birds studied carefully to eliminate other species.
