Overcast, but fairly bright lighting.

10. Optical equipment (type, power, condition): Zeiss 10x40 binocular.

11. Distance to bird(s): Perhaps about 150 meters.

12. Duration of observation: About 10 min or so.

13. Habitat: Shallow freshwater pool with some emergent vegetation.

14. Behavior of bird / circumstances of observation (flying, feeding, resting; include and stress habits used in identification; relate events surrounding observation): Originally seen in the company of other waterfowl, it was preening, then swimming actively through groups of other birds. It did not appear to be associating with any other individuals (ie: not paired). Eventually, it retreated back into denser vegetation where it appeared to be feeding.

Description (include only what was actually seen, *not what "should" have been seen;* include if possible: total length/relative size compared to other familiar species; body bulk, shape, proportions; bill, eye, leg, and plumage characteristics. A medium-sized dabbling (*Anas*) duck with a largely gray body, pinkish breast, and distinctive rufous head with buff longitudinal stripe extending from bill base to at least mid-crown. Bill was bluish with black nail.

17. Similar species (include how they were eliminated by your observation): American Wigeon (also present) has different head pattern and pinkish color along flanks.
