Eurasian Wigeon, *Anas penelope*

3. Locality: LOUISIANA: (parish) (specific locality)

Cameron Parish, Cameron Prairie National Wildlife Refuge, Pintail Loop. Found in grassy impoundment north of road about ¼ mile from entrance near parking area for board walk. Bird was at least 150 yards from the road.

Overcast, early afternoon. No appreciable shadows.

10. Optical equipment (type, power, condition):

Eagle Optics Raven Scope – 40 X, fair condition and Zeiss 10 x 42 binoculars, good condition.

11. Distance to bird(s):

150-200 yards.

12. Duration of Observation:

On and off for about 35 minutes.

13. Habitat:

Managed marsh impoundment for waterfowl habitat. Shallow openings and emergent vegetation, mostly grasses and sedges.

14. Behavior of bird/circumstances of observations (flying, feeding, resting; including and stress habits in identification: relate events surrounding observation):

Bird was in company with at least a dozen American Wigeons and mixed ducks including Northern Pintail, Northern Shoveler, and Green-winged Teal along with a few Snow Geese. Bird was actively feeding during the entire period of observation. From time to time, it was out of sight behind emergent vegetation.

15. Medium-sized puddle duck. Distinct orange-red head and cream-colored crown. Body mostly gray.

Bird was silent.

American Wigeon. American Wigeon male has white crown but has green eye stripe and gray face.
