- 11. Optical equipment (type, power, condition): Nikon Prostaff 3S, 10x42, great condition; Nikon Coolpix P1000 digital camera 24-3000mm, 125x optical zoom.
- 12. Distance to bird(s): Approximately 200', then 300' up to 600'.

- 14. Habitat: Rural/Urban around busy highway lined by open fields with houses behind a fenced line.

Behavior of bird / circumstances of observation (flying, feeding, resting; include and stress habits used in identification; relate events surrounding observation): Perched on electrical pole; looking around at ground and sky; flew to open field, did not catch anything that I am aware of; flew over my vehicle to another pole approximately 500' away.
- 16. Stress features that separate it from similar species):

Large bulky raptor, head was dark with streaks of white mixed in, dark thick eye stripe, long yellow gape extending under the eye with a dark hooked beak. The tail was long and white with white under-tail coverts. Tail in flight had brown feathers also. Belly was mostly white but had some rusty/brown streaking which was more spotted but in a line along the flanks. Rusty colored feathers covered the legs all the way down to the yellow feet. On the side of his neck area down to the shoulder there was dark streaking. When flying, I observed gray feathers on the back and brown at the rump. On my photos for the wings, I can see brown feathers on the Lesser Coverts blending to gray on the Median Coverts with gray into the secondaries, and white feathers on the primaries and black wing tips! The wings also had white on the extreme edge of the secondaries and primaries! Wowza! Similar in size and shape to that of a RTHA except the tail of the FEHA was longer and not red. Also, the wings of the FEHA extended much further down past the tail than a RTHA's which stood out to me and could be seen in photographs how long they are. A beautiful bird!
