Behavior of bird / circumstances of observation (flying, feeding, resting; include and stress habits used in identification; relate events surrounding observation): **Loafing with ca. 5000 gulls, mostly Ring-billed, after presumably feeding at dump. Of minor interest is that as it warmed up, this was the only gull that was panting.**
15. Description (include only what was actually seen, *not what "should" have been seen*; include if possible: total length/relative size compared to other familiar species; body

bulk, shape, proportions; bill, eye, leg, and plumage characteristics. Stress features that separate it from similar species, *or for species that are known to hybridize frequently, stress features that help eliminate possible hybrids*): Picked out by large size, towering over even nearby Herring Gulls. Then, the very large, all-black bill stood out from any of the other gulls' bills as well. Photos make a detailed description redundant. This was a fairly pale-headed, pale-chested, large gull with especially large bill and highly patterned back.

16. Voice: **Silent**

17. Similar species (include how they were eliminated by your observation): **Lesser Black-backed is only other immature gull with such a pale head and patterned back, but that species' bill would not appear so disproportionately large, and a LBBG would not have towered over adjacent HEGU.**
