At one point harassed by a Herring Gull and ran away, another time harassed by a 1st winter Lesser Black-backed Gull and ran away but then raised its wings and head, opened its bill fully, and

A large, whitish gull with dark eye, pink bill with well-demarcated black tip, vivid pink legs.

Larger than all gulls in the field, long, low-slung, very hefty. Back appeared to have glacial gray scapulars and mantle and there were almost no markings dorsally, except for perhaps a few very faint dots, which made me think 2nd winter. However, the eye appeared dark.

16. Voice: I was unable to hear it given the distance and the number of birds present, but it did bugle out something at one point.

17. Similar species (include how they were eliminated by your observation): No other species has the combination of body and soft part color. The bird was textbook Glaucous in size, color, and soft part color so hybrid can be ruled out.
