- 8. Other observers who independently identified the bird(s): Found during Creole CBC by Rob Dobbs and Paul Klerks. See by others that day (e.g., Chris Brantley, Heydi Lopes). I know others have seen/heard it (e.g., Katie Barnes, James Smithers, Van Remsen, and probably lots of others).
- 9. Light conditions (position of bird in relation to shade and to direction and amount of light): Clear, 10 mph winds. Bird was heard only.
- 10. Optical equipment (type, power, condition): Recording with Samsung FE23

smartphone in excellent condition.

- 11. Distance to bird(s): I was as close as 30 feet from the bird. First heard a good 100 ft away.
- 12. Duration of observation: About 10 minutes.
- 13. Habitat: Scrub dominated by *Iva frutescens*.
- 14. Behavior of bird / circumstances of observation (flying, feeding, resting; include and stress habits used in identification; relate events surrounding observation): Staying low in dense vegetation.
- 15. Description (include only what was actually seen, *not what "should" have been seen;* include if possible: total length/relative size compared to other familiar species; body bulk, shape, proportions; bill, eye, leg, and plumage characteristics. Stress features that separate it from similar species, *or for species that are known to hybridize frequently, stress features that help eliminate possible hybrids*): Heard only.
- 16. Voice: Heard giving squeaky, nasal "tuaw" call. Audio
- 17. Similar species (include how they were eliminated by your observation): Not as much of a growl as Spotted Towhee, and not as clean and rising as Eastern Towhee. A pretty distinctive call, and I can't place anything else that sounds very similar.
- 18. Photographs or tape recordings obtained? (by whom? attached?): Recordings by me, attached.
- 19. Previous experience with this species: I saw and heard about a dozen during the big GTTO outbreak into LA about 15 years ago, and have since seen/heard a few out west.
