The bird was standing on the beach and allowed us a close approach. It seemed to be resting.

We saw the bird at a distance, and, recognizing it as a white morph of the Great Blue Heron, approached more closely to take a photo to document it. Its size indicated a large heron, but it coloration was NOT that of a GBHE. It was too big for a Great Egret, and the legs were all wrong (pale rather than black). The beak was not the bright gold of a GREG.

- 16. Voice: The bird did not call.
- 17. Similar species (include how they were eliminated by your observation): Great Blue Heron/Great Egret: To distinguish this bird as a Great White Heron, we noticed the size of a GBHE without the characteristic coloring, the long neck, heavy yellow bill, and the pale legs.
- 18. Photographs or tape recordings obtained? (by whom? attached?): Single photograph from a Canon Powershot SX70HS. I cropped the photo slightly to upload it to eBird.
- 19. Previous experience with this species: Seen in Florida several times and once on the coast of Texas near Texas City.
