- 9. Light conditions (position of bird in relation to shade and to direction and amount of light): Bird was along the shoreline and in the direct sunlight facing west along the bank.
- 10. Optical equipment (type, power, condition): Binoculars at 12x20 and iPhone camera, but we able to get surprisingly close to the bird and took multiple photos. Do believe on a future trip we can pinpoint exact location via gps.
- 11. Distance to bird(s): Single bird, limpkin and we were less than 10 feet away in kayaks.

- 12. Duration of observation: Up to five minutes, truly until we had taken multiple pictures and decided to let him/her be.
- 13. Habitat: Swamp habitat appeared to be hunting food along the shoreline in the vegetation along the bank.
- 14. Behavior of bird / circumstances of observation (flying, feeding, resting; include and stress habits used in identification; relate events surrounding observation): I am an amateur birder at best it did seem to me that the bird was too calm to be that close to people. It was very relaxed, only flew back a few feet and relocated when we floated in less than 5 feet away, did not startle and calmly flew to next perch.
