- 2. Number of individuals, sexes, ages, general plumage (e.g., 2 in alternate plumage): 1 apparent adult.
- 3. Parish: East Baton Rouge Specific Locality: Walden Rd off Kennilworth Dr, Baton Rouge.
- 4. Date(s) when observed: 23 March 2020

- 7. Other observers accompanying reporter who also *identified* the bird(s): Two other birders were present, but I never asked their names.
- 8. Other observers who independently identified the bird(s): First identified by Jane Patterson (receiving the first report from a resident of the neighborhood), seen by many observers between 21-30 March. Subsequent searches did not turn up the bird.
- 9. Light conditions (position of bird in relation to shade and to direction and amount of light): Good lighting (see photos).
- 10. Optical equipment (type, power, condition): Zeiss 10x40 bins
- 11. Distance to bird(s): about 20 m.

- 12. Duration of observation: about 30 min
- 13. Habitat: semi-manicured cypress-studded pond in neighborhood.
- 14. Behavior of bird / circumstances of observation (flying, feeding, resting; include and stress habits used in identification; relate events surrounding observation): Calm, mostly foraging in shallow water of pond or on dry ground around the base of a baldcypress, when preening. Captured and ate a small mussel while I observed it.
- 15. Description (include only what was actually seen, *not what "should" have been seen*; include if possible: total length/relative size compared to other familiar species; body bulk, shape, proportions; bill, eye, leg, and plumage characteristics. Stress features that separate it from similar species, *or for species that are known to hybridize frequently, stress features that help eliminate possible hybrids*): Large wader, body size approximately of Great Egret, but with a shorter neck (and not "folding" as in a heron). Largely brown with white streaking from head to back, undersparts, and wing coverts. Long, slightly drooping dull orange bill with darker culmen and tip. Dark legs.
- 16. Voice: None heard (even after playing back to it to elicit a response).
- 17. Similar species (include how they were eliminated by your observation): None.
