12. Duration of observation: 2 minutes, during which it came down and took a bath and posed numerous times at different angles.

13. Habitat: Dense scrubby coastal shrubbery.

14. Behavior of bird / circumstances of observation (flying, feeding, resting; include and stress habits used in identification; relate events surrounding observation): It was inquisitive and investigated the water dish and took a bath. See video on eBird report for actions.

Darker back was a gray/green in color, dark gray hood, prominent broken eye-ring which was broad and not very long. Each was a quarter way around the top and bottom on the eye, two tone bill darker on upper mandible and fleshy colored on lower mandible. Fleshy colored legs.

16. Voice: none that I could hear.

17. Similar species (include how they were eliminated by your observation): Most similar species have complete eyerings, such as the COYE, OCWA, COWA. The Mourning Warbler does not have the wide and quarter round eye arcs like this warbler.
