- 9. Light conditions (position of bird in relation to shade and to direction and amount of light): Excellent (see photos)
- 10. Optical equipment (type, power, condition): Primarily Swarovski 25-60x spotting scope.
- 11. Distance to bird(s): on 19th, no closer than 150 m. On 22nd, initially spotted at about

- 12. Duration of observation: Approx 2 hrs, 40 min in total
- 13. Habitat: shallow settling pond in impoundment.
- 14. Behavior of bird / circumstances of observation (flying, feeding, resting; include and stress habits used in identification; relate events surrounding observation): Mostly sitting on water with Ring-bills, but typically posture was more like Bonaparte's with neck stretched up and looking down into water. The second visit allowed us some views on the beach before it flew out into pond and sat on water. Brief views flying both visits.
- 15. Description (include only what was actually seen, *not what "should" have been seen*; include if possible: total length/relative size compared to other familiar species; body bulk, shape, proportions; bill, eye, leg, and plumage characteristics. Stress features that separate it from similar species, *or for species that are known to hybridize frequently*, *stress features that help eliminate possible hybrids*): Medium-sized gull (slightly smaller, more slender in build) than Ring-bills, with which it could be easily compared. Wing projection noticeably longer. Bill shorter, thinner, with greenish subterminal band. Feet dull greenish-yellow. Eye dark, accentuated with dark feathering around it. Light mottling on crown and rear of head, with darkest patches on center of nape. Mantle and upperwing darker gray than Ring-bills (not as dark as a Laughing, however). Noticeable white patch at back end of scapulars and broader white crescent of closed secondaries allowed us to find the bird on the water as it faced away from us and into the wind. Open wings showed two white mirrors on P10 and 9, and subterminal black as far back as P4, "string of pearls" interior from black forward towards wingtip until P7. This wingtip pattern suggests American subspecies *brachyrhynchus* over *canus* or *kamtschatschensis*.

- 17. Similar species (include how they were eliminated by your observation): Direct comparison to Ring-billed Gull. No other medium-sized gulls similar.
