Behavior of bird / circumstances of observation (flying, feeding, resting; include and stress habits used in identification; relate events surrounding observation): Found flying and landing in a patch of Turk's Cap off Post Lane as reported by previous observers. It did not seem to be disturbed by our presence. It stayed in the same general area until hunters began firing shotguns not far from us, then flew away to the east and did not return while we were there.

The body was overall greenish with dark blue wings and a very bright blue patch near the base of the tail. Longish downcurved dark bill.
