This was a medium-sized bird with gray back and burnt orange belly. I saw the bird clearly in two scopes and with my binoculars in the morning. I saw the bird clearly with my binoculars in the afternoon. In the afternoon, I was unable to take pictures as it was chased across the road by a male Vermilion Flycatcher. Noticed it slowly and strongly pumping its tail before being chased away.

Bird was silent.

In this case, the bird resembled in size and behavior an Eastern Phoebe but color pattern was wrong for Eastern Phoebe and it seemed a bit too large.
