14. Habitat: Cypress swamp area with mix of wooed and some open fields. This swampy area has a huge apple snail population and many Limpkins that dwell/feed there. I learned the Snail Kite feeds upon Apple Snails, so it makes sense that there was food availability.

15. Behavior of bird / circumstances of observation (flying, feeding, resting; include and stress habits used in identification; relate events surrounding observation): My wife and I frequent this particular area regularly for bird/wildlife photography.

It is a pipeline/oil & gas operation with private access only. We have permission to photograph there.

On the morning of Friday July 5, 2024, I first observed a large dark raptor perched upon a small dead tree about 6 ft. above a swampy area. It was facing away at first. I wasn't sure what it was due to its unfamiliar appearance.

I used AllaboutBirds.org website on my phone to get an ID. Found a match and confirmed it was a Snail Kite after photographing it both perched and in flight. My wife got photos of the same. Once this Kite flew away, we never saw it return to that area. We also went back to the location on July 7, 2024 but never saw another sign of this one or any other Snail Kites.

I have photographs that clearly show this raptor's features. The bright orange curved-downward bill confirmed the ID.
