9. Light conditions (position of bird in relation to shade and to direction and amount of light): Fair to good. Initially the birds were silhouetted, but eventually they were seen in good light.

10. Optical equipment (type, power, condition): Eagle 8x42 bins

11. Distance to bird(s): 10-20 m

12. Duration of observation: On and off for 50 minutes

13. Habitat: Wooded and scrubby area next to Hwy 82.

14. Behavior of bird / circumstances of observation (flying, feeding, resting; include and stress habits used in identification; relate events surrounding observation): Perching and flying.

Description (include only what was actually seen, *not what "should" have been seen;* include if possible: total length/relative size compared to other familiar species; body bulk, shape, proportions; bill, eye, leg, and plumage characteristics. Stress features that separate it from similar species, *or for species that are known to hybridize frequently, stress features that help eliminate possible hybrids*): The apparent male had a black head and the apparent female had a chocolate-colored head. The breast and belly of both were white to off-white with rufous flanks. Both had red eyes. They had white wing bars without a hint of the white primary patch that EATO has. There was extensive white streaking on the primary coverts, scaps/back, and tertials.

16. Voice: Harsh mewing call

17. Similar species (include how they were eliminated by your observation): Extensive streaking and absence of white primary patch eliminates EATO and minimizes the likelihood of hybridization.
