1. English and Scientific names: Tropical kingbird Tyrannus melancholicus

- 3. Parish: Orleans Specific Locality: Eastover, in the abandoned golf course.

9. Light conditions (position of bird in relation to shade and to direction and amount of light): Overcast. Bird out in the open at first, but a little too far for photo. It came in closer, but in trees, so photo was taken in shade.

10. Optical equipment (type, power, condition): Steiner 8x42 and Canon rebel T3i with Sigma 70-300mm lens.

11. Distance to bird(s): at first, about 50ft, then flew in closer in response to player, about 30ft.

12. Duration of observation: 10 minutes

13. Habitat: Overgrown golf course with shoulder high weeds around 2 small lakes. We

were on the golf cart path, the other side of path was a wooded area that was only about 40ft deep, then the service road.

14. Behavior of bird / circumstances of observation (flying, feeding, resting; include and stress habits used in identification; relate events surrounding observation): Bird seen earlier in the day. We played the call and it appeared. It was quiet, but inquisitive. Did not forage or rest, didn't look stressed.

Bright yellow underparts, Light gray head with dark line through eye, large black bill.

16. Voice: Silent, but was heard earlier in the same day.

17. Similar species (include how they were eliminated by your observation): Eliminated from Couch's due to vocalization. Also the size of it's bill was larger than a Couch's.
