- 13. Habitat: Sky over broad-leafed riparian trees adjacent to a lake
- 14. Behavior of bird / circumstances of observation (flying, feeding, resting; include and stress habits used in identification; relate events surrounding observation): Flying with constant fast, fluttery wingbeats with lots of short, erratic turns and no gliding during the minute or so of observation.
- 15. Description (include only what was actually seen, *not what "should" have been seen;* include if possible: total length/relative size compared to other familiar species; body bulk, shape, proportions; bill, eye, leg, and plumage characteristics. Stress features that separate it from similar species, *or for species that are known to hybridize frequently, stress features that help eliminate possible hybrids*): Two small Chaetura observed low over north parking lot at about 16:56. Jizz immediately said Vaux's, based on size, flight style, and impression of wing shape. Constant fast, fluttery wingbeats with lots of short, erratic turns and no gliding during the minute or so of observation. Wings appeared shorter with no noticeable pinch at the secondaries as would be expected in Chimney. Silent. No plumage coloration details noted.
